# State Agency Resolution Requirements

- List Company requesting Nomination
- Date & Time of Agency Board Meeting
- Agency Owns Minerals
- Agency desires State Mineral & Energy Board to act on its behalf (accept nominations, advertise for, accept and award bids, and execute all mineral leases)
- Describe property on Exhibit "A"
- Additional conditions, minimums and rentals on Exhibit "B"

 60 days from last signature date, \$100/day (caps off at \$1,000)


